Motion to accept the 2021 annual meeting minutes as written. Daniel Kea, 2nd-Theresa Sommer, Motion passed. Minutes approved.

Treasurer's Report - Kris Scanlon

Treasurer reports that VCARMC has \$64,863.08 in its checking account with no outstanding payments due. The insurance policy is due in March.

The assessment letters will be mailed at the end of October. Assessments are the same as last year:

1/2 acre - \$200

1 acre - \$400

5 acre - \$500

Assessments last year were doubled from 2020. Total assessments for the subdivision have gone from \$19,000 to \$38,000. Kris has reduced payment delinquencies from 25 to 16 owners. \$7,900 is past due. 3 owners have never paid.

Motion to approve Treasurer's report Casey Kinney, 2nd Mike McKenney. Motion passed.

By-Laws Change Report- Theresa Sommer, Ina Wolfe

A proposal to change VCARMC by-laws was sent to all owners inn the 2021 newsletter. Proposal to no longer require submission of a resume 45 days in advance of the annual meeting to put forth a name for board membership. The only requirement is to put forth the name for consideration at the annual meeting or anytime prior.

82 owners voted YES, 15 owners voted NO, 40 non response. Approved with over 3/4 voting in favor (according to by-laws)

Annual Dues Increase - Theresa Sommer

As of 2024, VCARMC assessments will increase by 10%/ per year as allowed in the VCARMC by-laws.

Roadside Maintenance - Casey Kinney

We have a new roadside maintenance company - Zachscapes. Licensed and Bonded. Will be providing road easement clearing and mowing quarterly. Bud Muth suggests a wider easement mowing on Laukapu. Casey will follow up.

Roundtable discussion of roadside herbiciding. The following was agreed upon: Ke Koa Nui, Olomea and Laukapu Rd - from Rd C to Wright Rd. - Julie Kalaninauli - Bud Kawailehua, Olomea and Laukapu -from Kawailehua to Rd. C. - Theresa Road C- Mike McKenney

Casey states that asphalt patching material is needed . Kris will buy the material (needs to be used right away to prevent hardening). Theresa has a large torch.

New Business

Ina reports that there are 4 openings on the board and explained the basic duties. New VCARMC board members joining Mark Bowser Gigi Lee Marlene Hartley Michael Stacy Each of the new members has agreed to a 3 year commitment.

Of the ongoing board members: Ina Wolfe , Theresa Sorner, and Daniel Kea have agreed to one more year Bud Muth , Kris Scanlon, and Casey Kinney have agreed to 2 more years
